1. 上表配息頻率欄位為月配之基金

■配息率=〈每單位配息金額÷除息日前一日淨值〉×100%。

■報酬率〈含息〉=〈月底淨值-上月底淨值+上月配息金額〉÷上月底淨值。報酬率(含息)計算係指將收益分配均假設再投資本基金，上表為近期各月份加計收益分配後之月報酬率。舉凡成立第一個月配息者，該次「報酬率」欄係指成立日至該月底之報酬率。

2. 上表配息頻率欄位為季配之基金

■配息率=〈每單位配息金額÷除息日前一日淨值〉*100%。

■報酬率〈含息〉=〈季底淨值-上季底淨值+上季配息金額〉÷上季底淨值。報酬率(含息)計算係指將收益分配均假設再投資本基金，並以各季度加計收益分配後之季報酬率。

3. 上表配息頻率欄位為年配之基金

■配息率=〈當年度每單位配息金額÷除息日前一日之淨值〉x100%。

■報酬率〈含息〉=〈年底淨值-前一年底淨值+前一年配息金額〉÷前一年底淨值。報酬率(含息)計算係指將收益分配均假設再投資本基金，並以當年度加計收益分配後之年報酬率。

如為成立未滿一年之首次配息者，該次「報酬率」欄係指成立日至該曆年底之報酬率。

5. 股票型基金在配息政策上主要是運用所投資之個股，在該公司有盈餘分配的情況下，所發放之現金股利，且該收入不一定具有定期給付之特性，該類基金之每月配息將視整體基金收益及淨資產價值之情形運作，此配息結果可能涉及本金。柏瑞特別股息收益基金(本基金並無保證收益及配息且配息來源可能為本金)在配息政策上主要是運用所投資之特別股個股，在該公司約定條件下，所發放之現金股利，且該收入多數具有定期給付之特性。本基金之配息將視整體基金收益及淨資產價值之情形運作，此配息結果可能涉及本金。柏瑞環球-柏瑞環球重點股票基金(基金之配息來源可能為本金)-本基金ADC(穩定月配)級別美元之可分派收益來源為股息收入及已實現和

未實現淨資本利得，且可能來自於本金。基金配息率(或金額)之決定是根據已取得之資本利得及股息收入等收益來源狀況，並考量基金經理對於未來市場看法，若因為市場因素造成配息來源狀況不佳，將可能調整目標配息率(或金額)，詳細分派政策請詳基金公開說明書。
